### Fund Objective

The objective of the portfolio is to provide investors with a moderate to high long-term total return.

### Fund Strategy

The portfolio will invest in a combination of assets in liquid form, money market instruments, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities, derivatives, non-equity securities and any other securities which are considered to be consistent with the portfolio's primary objective and the Act. The manager may also include unlisted forward currency, interest rate and exchange rate swap transactions for efficient portfolio purposes. The portfolio will be actively managed with exposure to various asset classes being varied to reflect changing economic and market circumstances, in order to maximize returns for investors. The portfolio shall limit equity exposure to 75%. The portfolio will be managed in accordance with regulations governing pension funds.

The manager decreased the annual management fee on 1 October 2017 to 1.25% from 1.53%.

Total Expense Ratio (TER) is the percentage value of the Financial Product that was incurred as expenses relating to the administration of the Financial Product. Total Investment Charges (TER + TC) is the total percentage value of the Financial Product that was incurred as costs relating to the investment of the Financial Product.

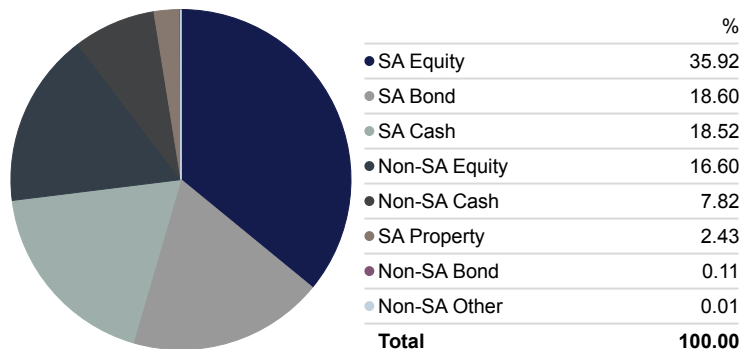

### Risk Profile: Moderate Aggressive

In this portfolio, capital growth is of primary importance and results in a higher allocation to equities. The portfolio may display capital fluctuations over the shorter term, however, volatility levels should be lower than a pure equity fund. While diversified across all the major asset classes, this portfolio is tilted more towards equities and other risky asset classes to ensure the best long-term returns of all the asset classes. Fixed income positions are minimized.

### Glossary Terms

#### Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

#### Asset Allocation

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

#### Capital Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or capital value fluctuates over a certain period of time. Funds with high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

#### Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

#### Derivatives

Derivatives are instruments generally used as an instrument to protect against risk (capital losses), but can also be used for speculative purposes. Examples are futures, options and swaps.

#### Distributions

The income that is generated from an investment and given to investors through monthly, quarterly, bi-annual or annual distribution pay-outs.

#### Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

#### Financial Instruments

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

#### Fund Objective

The fund objective is the portfolio's core goal.

#### Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

#### Information Ratio

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

#### Collective Investment Schemes

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buy units. They allow private investors to pool their money together into a single fund, thus spreading their risk across a range of investments, getting the benefit of professional fund management, and reducing their costs.

#### Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue.

#### Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

#### Participatory Interests

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

#### Performance Fee

Performance fees are incentive fees earned by the manager for performance in excess of the benchmark.

#### Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

#### Standard Deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the volatility expected of an investment.

### Portfolio Manager Comment

The South African equity market returned +1.5% in November taking its year-to-date (YTD) total performance to +21.5% in Rand terms. SA Financials delivered the best performance, posting a total return of +4.4% with both SA Banks (+8.3%) and SA life Insurers (+6.5%) delivering strong results. The South African resource index detracted from market performance posting a negative -1.6%, while the industrial index was steady at +1.4% during the month.

#### Local Equity Exposure

While the SA mid-cap index showed improvement in November recording a gain of +2.3%, YTD it has underperformed the large-cap index by almost 20%. Although the uncertain political and weak economic environment continues to impact investor confidence and weigh on the performance of local interest and GDP sensitive stocks, we remain positive on the significant upside that a number of our stocks offer at this point in time.

The fund benefitted from being overweight SA financials and in particular strong performances from core holdings in Sanlam (+10.7%) and Barclays Africa (+12.6%) during the month. We also saw the rebound of Sun International (+8.5%), Brimstone (+5.4) and Woolworths (+3%) which positively contributed to performance.

After the fund's strong showing in October, our local equity performance was effectively flat in November. Being half index weight in Naspers (Naspers contributed 1.39% of the ALSI TR of 1.3% therefore the balance of the market delivered a negative return) was the main reason for this.

#### Offshore Equity Exposure

High offshore exposure was maintained and was impacted by ZAR strength, which rallied against the USD by 3% in November. In USD terms, the offshore equity component contributed positively to performance as offshore equities continued to rally (MSCI World: +2.2%). Largest contributors included Union Pacific (+9.8%), Boeing (+7.8%) and Moody's (+6.9%) while the fund's largest detractors were Cognizant (-4.8%) and Reckitt Benckiser (-1.9%).

#### Fixed Income

Our fixed income exposure produced a flat return for the month which we consider a positive result considering the ALBI being down 1% in November and the middle of the curve down 1.7%. Inflation linked bonds at an index level fell 3% whereas property gained 1.5%.

#### Concluding remarks

We are positive that the portfolio is suitably positioned accounting for the environment being faced. The Northstar SCI Managed fund consists of high quality businesses and a good mix of rand hedges with domestic focused companies. All trade below our deemed view of their intrinsic values.
